### Income

### **Grant from St Edmundsbury Borough Council**

St Edmundsbury Borough Council cut its Parish Council Support Grant and its Council Tax Support Grant by 25% in 2015.

## **VAT Refund**

Stradishall Parish Council claims back VAT at the end of each financial year. It claimed less VAT in 2015/16 as it purchased fewer goods and services in 2014/15 on which the VAT could be reclaimed.

### **Councillor training**

No training was undertaken in 2015/16

#### Phone costs

Stradishall Parish Council paid a lower amount to Risby Parish Council for its share of phone costs as Risby Parish Council took out a new, cheaper contract in August 2015.

#### **Election costs**

St Edmundsbury Borough Council charged Stradishall Parish Council £21.34 for the cost of an uncontested election in May 2015

#### Membership of LCPAS and Community Action Suffolk

Stradishall Parish Council left SALC and took out membership with LCPAS at a cost of £80, a reduction of £141.

#### Audit fees

No audit fee of £100 was paid to BDO LLP in 2015/16. £65 was paid to the Council's internal auditor

#### **S137**

A donation of £50 was made to Suffolk Accident Rescue Service in 2015/16

### Playing field/maintenance services (grass and hedge cutting, playing field repairs)

Stradishall Parish Council paid for repairs to play equipment following an annual play inspection report which had several findings which needed addressing.

#### VAT

The Council paid less VAT in 2015/16 as it purchased fewer goods and services on which VAT was payable

Stradishall Parish Council increased its donation to St Margaret's Church towards the cost of maintaining the church yard.
